

Step 1 –

Register for a username and password at www.mynpp.com

- Choose “Commercial Contractors”.
- Choose local chapter that your organization belongs to.
- Fill in remaining required information and press register.
- Your username and password will be returned within 24 hours from NPP


Upon receiving username and password information, return to www.mynpp.com the following business day after 2pm EST and follow the steps below:
